Homeowners Association Service and Membership Agreement

[Includes Mark Alcorn suggested revisions]

In order to satisfy Condition of Approval No. _____ of the Cove Subdivision Agreement between ______ and _____ as recorded in Book _____ and Page ____ on ____[date]____, the parties, the South Natomas Transportation Management Association (SNTMA) and The Cove Homeowners Association (Member, also known as "Cove Community Association"), agree as follows:

1. SNTMA shall work cooperatively with the designated "Primary Representative" of Member on transportation management and air quality issues to develop and operate successful trip reduction programs that help reduce traffic and improve air quality in and around the vicinity of the development known as The Cove.

2. Member is hereby admitted as a Residential Developer Member of SNTMA. Member agrees to abide in the terms of this Agreement, SNTMA Bylaws, SNTMA written rules and policies, and the decisions of duly constituted committees of SNTMA.

3. Member shall not be a member of SNTMA within the meaning of the California Corporations Code. Member shall designate in writing a Primary Representative and up to three additional representatives to serve on SNTMA committees and/or hold office, none of whom shall have the right to vote, regardless of SNTMA office held.

4. Member dues shall be set by the Board of Directors of SNTMA and are subject to change from year to year upon sixty (60) days prior written notice. Dues increases shall be approved by the Board of Directors of the SNTMA as necessary. Initiation fees are \$10,000.00, payable upon execution of this Agreement. Initial dues for 2019 shall be \$60 per year per residence, based on the total number of units annexed into the Cove Community Association annually. Annual updates of annexed homes for The Cove in the immediate prior year shall be submitted by the Cove Community Association to the SNTMA no later than January 15th of each calendar year. Dues shall be paid not later than March 15th of each calendar year for that calendar year. SNTMA will issue an invoice to Member based upon the total number of units in the Cove Community Association plan. Dues paid shall not be refundable.

5. The parties agree that participation in this Agreement does not constitute approval or endorsement of any goods, services or entity. No partnership or joint venture is intended by this Agreement; each party is an independent entity. Other than as set forth in this Agreement, no party may represent or bind the other to any obligation. No license to use or convey the trademarks or other intellection property of either party to this Agreement is intended by this Agreement.

6. This Agreement may be terminated by mutual agreement of the parties, or upon the dissolution of the Member or SNTMA, whichever occurs first.

7. Any controversy or claim arising out of or relating to this contract, or the breach thereof, shall be settled by arbitration administered by the American Arbitration Association in accordance with its Commercial Arbitration Rules, and judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof.
