\$25 Telework Subsidy

There are **eighty** monthly \$25 telework subsidies on a first come, first served basis. Enter ten round trip telework days (miles saved in both directions) in your norcalgo.org Trip Calendar.

Residential Car Charging Station Subsidy

There are **thirteen** Residential Charger Subsidies remaining for this calendar year, maximum amount \$250, available on a first come, first served basis. The charger must have been purchased within 90 days of redeeming the subsidy. Receipt(s) and photo of the installed charger must be uploaded to NorCal Go when redeeming. There is no Trip Calendar requirement to redeem this subsidy through norcalgo.org.

Low Emissions Vehicle Subsidy

There are **thirty** \$50 monthly Low Emissions Vehicle subsidies available on a first come first served basis. Select "drive alone" then enter your LEV information. Enter ten round trip or twenty one-way commute to workdays in your norcalgo.org Trip Calendar. Your vehicle must be a low emissions vehicle to participate in this program. ***Low Emissions Vehicle subsidy participants will need to initially provide the SNTMA with their vehicle information at Stephanie@sntma.org.*** The norcalgo.org system only counts "greener trips" as trips made by carpool, vanpool, transit, biking, walking, or working from home. Those vehicle trips are not included in the "Your Activity" chart for greener trips on your "home" screen.

Carpool Subsidy

There are **fifteen** \$50 monthly Carpool subsidies available on a first come, first served basis. Enter ten round trip or twenty one-way Carpool to workdays in your norcalgo.org Trip Calendar. ****Carpool groups must initially provide the SNTMA with their group's work contact information at Stephanie@sntma.org***

Bike Maintenance and Accessory Subsidy

There are **three** \$100 bike Maintenance and Accessory subsidies available every month. Each employee of an SNTMA member company is eligible for one Bike Maintenance & Accessory subsidy per calendar year. Enter ten round trip or twenty one-way bike commutes to work in your norcalgo.org Trip Calendar.

Ridepanda Subscription Subsidy

There are **five** \$50 monthly Ridepanda Subscription subsidies available on a first-come, first served basis. Ridepanda offers a flexible way to get around with monthly subscriptions for e-bikes, pedal bikes, and scooters. Employees of our member companies can subscribe at https://get.ridepanda.com/south-natomas-tma/sacramento_ca

Enter ten round trip or twenty -way bike commutes to work in your norcalgo.org Trip Calendar. When you redeem the subsidy, upload a copy of your monthly receipt. Ridepanda Subscription Subsidy flier with details is on our website and Facebook page.

Walk Subsidy

There are **four** \$100 Walk subsidies available on a first come, first served basis remaining for the calendar year. The Walk subsidy is for walking trips between home and office. Each employee of an SNTMA member company is eligible for one Walk subsidy per calendar year. Enter ten round trip or twenty -way walk commutes to work in your norcalgo.org Trip Calendar.

Transit Subsidy

There are **two** \$75 monthly Transit subsidies available on a first-come, first served basis. Enter ten roundtrip or twenty one-way transit commutes to work in your norcalgo.org Trip Calendar. When you redeem the subsidy, upload a copy of your monthly ticket.

Amtrak Subsidy

There are **two** \$50 monthly Amtrak subsidies available on a first-come, first served basis. The SNTMA Amtrak subsidy is for trips between home and your office in South Natomas. Enter ten round trip or twenty one-way Amtrak commutes in your norcalgo.org Trip Calendar, when you redeem the subsidy, upload a copy of your Amtrak multi-ride or monthly ticke

2026 YTD SNTMA Stats from NorCal GO

From January 1 to September 1, 2026, 227 employees of our member companies entered 33,294 commute trips in NorCal Go. Their average distance was 17.3 miles. Those 227 people reduced 29,819 trips, reduced 511,045 Vehicle Miles Traveled and saved 19,330 gallons of gas. They collectively reduced 189 tons of Co2 from our air, saved \$373,645 and burned 707,565 calories.
